

Coty Legal Entity changes due to the Wella business separation

- Due to Wella separation those Legal Entities that today are majority working for Wella business will remain in Wella Legal Entities structure and we will transfer the remaining Coty business (Consumer Beauty and Luxury) into a new Legal Entity.
- Business linked to that transition are related to Consumer Beauty and Luxury divisions.
- As of **30 November, 2020** we will transfer operations and billing to the new Legal Entity.
- Until that transfer date please continue operating with the same Legal Entity.
- Legal Entity mapping file will be updated in a weekly basis on the Coty supplier website.
